Order Correcting Decree.

Baker, for the entry of an order herein correcting certain clerical errors and omissions in the decree entered by this Court in the above entitled matter, and

It appearing to the Court that the State Water Board of Oregon, in its consideration of the above entitled matter, awarded the late E. D. Baker a relative priority of 1889 for 5.14 cubic feet per second from Sage Hen Creek and West Fork of Silvies River through a ditch without name for the irrigation of 410.81 acres of land described as:

And it further appearing to the Court that such award by the State Water Board to the late E. IL Baker was not appealed or disturbed in any way and that the foregoing data should be in the decree of this Court in the same identical form as it is above set out, and

It further appearing to the Court that in the preparation of the decree of this Court in said matter, certain clerical errors and omissions resulted in E. D. Baker being awarded a date of relative priority of 1889 for 5.14 cubic feet per second from Sage Hen Greek and West Fork of Silvies River through a ditch without name for the irrigation of 410.81 acres of land, and that in the description of the various subdivisions to which such right was appurtenant, but 332 acres of land were described and that the descriptions given in the Said decree covered lands in Section 19, Township 24 South, Range 31 E. W. M. which were not and are not now owned by the late E. D. Baker, or Martha Baker and Zelma Baker, his successors in interest, when the descriptions should have been shown as being within Section 24, Township 24 South, Range 30 B.W.M., and that the lands owned by the late E. D. Baker, and his successors in interest, in Section 19, Township 24 South, Range 31 E. W. M. described as 40 acres in NEASWA and 38.81 acres in NWASWA (Lot 3) were entirely omitted from the detailed description although included in the total acreage to which the right was awarded, and

It further appearing to the Court that these discrepancies have resulted very obviously from clerical errors and omissions and that corrections of appropriate character should be made, now therefore

IT IS CONSIDERED, ORDERED AND DECREED That the decree of this Court in the above entitled matter be corrected to show that E. D. Baker, and his successors in interest, has a date of relative priority of 1889 for 5.14 cubic feet per second from Sage Hen Creek and West Fork of Silvies River through a ditch without name for the irrigation of 410.81 acres of land described as follows:
